

RESULT NOTICE

1. Department of Forests & Wildlife, vide its Direct Recruitment Notice dated 27.12.2019 with closing date 16.02.2020 had advertised 211 vacancies (UR-88, OBC-57, SC-30, ST-15, EWS-21) for the post of Forest Guard in Department of Forests & Wildlife, Govt. of NCT of Delhi.
2. Department of Forests & Wildlife conducted computer based test for recruitment in respect of this post on 1st March, 2021 to 7 March, 2021.
3. Based on the performance in computer based test, 253 Candidates(UR-105, OBC-69, SC-36, ST-18, EWS-25), who obtained marks above or equal to cut off marks in their respective categories, have been provisionally shortlisted to appear in Physical Endurance Test and Physical Standard Test, subject to correctness of the information furnished by the candidates in their online application forms. Roll No. of Ex-Serviceman (UR-19, OBC-01, ST-01, UR Waiting-04) are also included in the aforementioned list of 253 candidates. The shortlisted candidates shall be called for Physical Endurance Test and Physical Standard Test.
4. The shortlisted candidates for the Physical Endurance Test and Physical Standard Test, who have appeared in Computer Based Test are contained at Annexure-1.
5. Only those candidates have been considered in OBC Category who have declared that they are OBC (Delhi) in their online application form.
6. Further, since documents have not been called from the candidates along with the online application forms, as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of names in the list of candidates provisionally shortlisted for appearing the Physical Test and Physical Standard Test does not entitle them any right over the post.
7. The above short-listing for Physical Endurance Test and Physical Standard Test for the post of Forest Guard in the Department of Forests & Wildlife, Govt. of NCT of Delhi will be subject to outcome of pending court case, if any.
8. While every care has been taken in preparing the result, Department reserves the right to rectify errors and omissions, if any detected at any stage.
9. The details of Physical Endurance Test and Physical Standard Test shall be notified separately by the Department. The candidates are hereby advised to check the website of the Department regularly.
